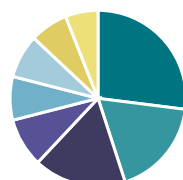

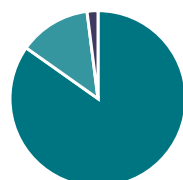

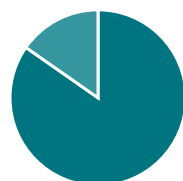
PORTFOLIO COMPOSITION 10/31/2020

MARKET CAP



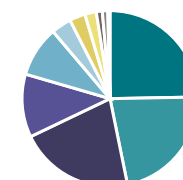
