INVESTMENT OBJECTIVES AND STRATEGY

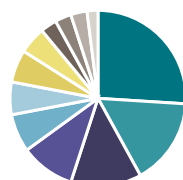

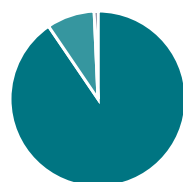

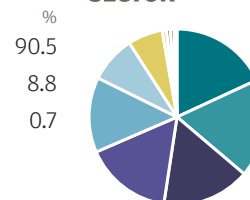
PORTFOLIO COMPOSITION 10/31/2020

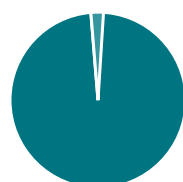
