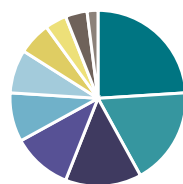

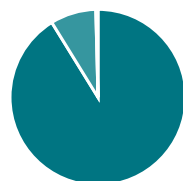

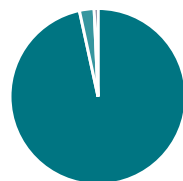
PORTFOLIO COMPOSITION 8/31/2021

MARKET CAP



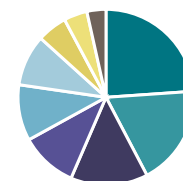
