## INVESTMENT OBJECTIVES AND STRATEGY

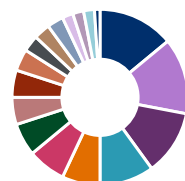

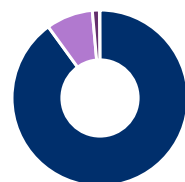

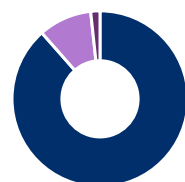
