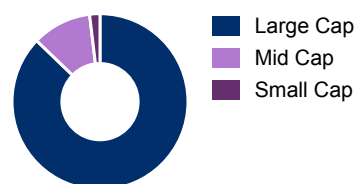

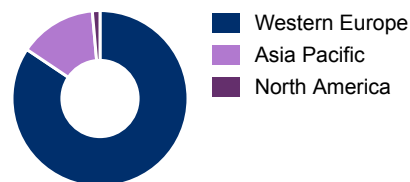

MARKET CAP



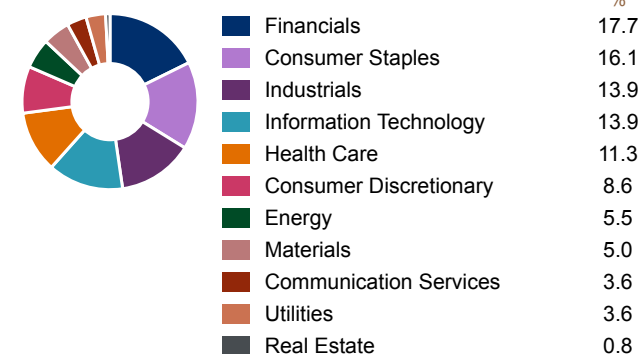
