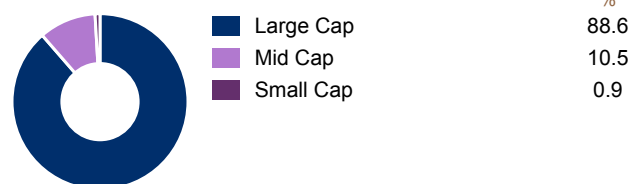

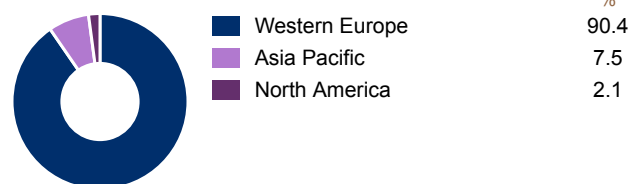

### MARKET CAP



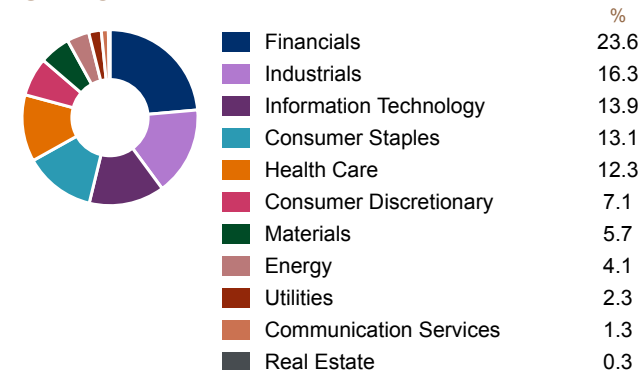
