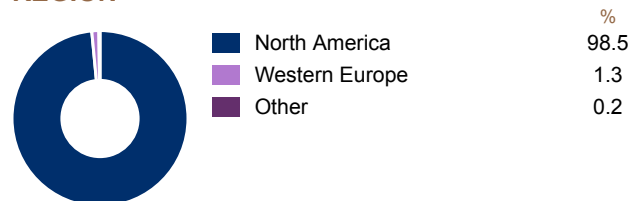

MARKET CAP



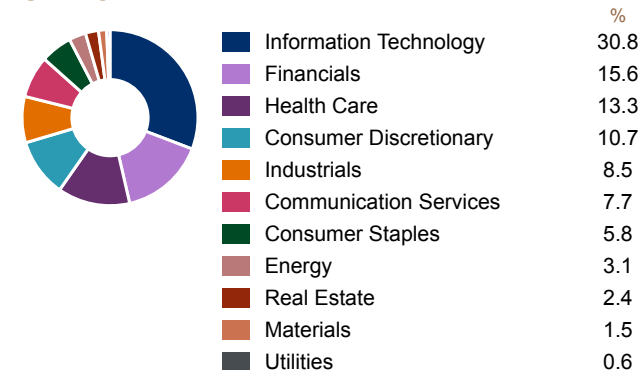
