

MANAGER COMMENTARY

We believe we are at or near the start of a new economic cycle. Accommodative monetary and fiscal policy have helped stabilize global economies and markets, while the prospects of a COVID-19 vaccine are fueling a continued rally. We believe, it will likely take until 2022 for absolute levels of growth to reach pre-COVID highs, we expect economic activity to continue to recover. In the near-term, we believe markets will continue to be volatile, as COVID-19 will likely damper economic activity until a vaccine is widely distributed. Equity markets are expected to be up over the next 12+ months.

FUND ALLOCATION 12/31/2020





Annual Operating Expenses

Morgan Private Investments Inc., and/or its affiliates have contractually agreed through at least 04/30/2021 to waive any management fees that exceed the aggregate management fees the adviser is contractually required to pay the Fund's sub-advisers. Such waivers are not subject to reimbursement by the Fund.

Additionally, the Fund's Adviser has contractually agreed through at least 04/30/2021 to reimburse expenses to the extent total annual operating expenses of a Fund excluding acquired fund fees and expenses, if any, dividend and interest expenses related to short sales, brokerage fees, interest on borrowings, taxes, expenses related to litigation and potential litigation and extraordinary expenses) exceed 0.40% of the average daily net assets of the Fund, respectively (the "Expense Cap"). An expense reimbursement by the Fund's Adviser is subject to repayment by the Fund only to the extent it can be made within thirty-six months following the date of such reimbursement by the Adviser.

GLOSSARY OF TERMS

Annualized Performance: This is used to show performance for periods of greater than one year and is also called compound rate of return. Annualized return measures an investment's increase in value each year, including capital appreciation and reinvested income.

Maturity: Maturity, as used herein, is the average effective maturity which is a weighted average of all the maturities of the bonds in a portfolio, computed by weighting each bond's effective maturity by the market value of the security. Average effective maturity takes into consideration all mortgage prepayments, puts, and adjustable coupons. Longer-maturity funds are generally considered more interest-rate sensitive than their shorter counterparts. The maturity may include the impact of derivatives.

Credit Quality: A debt issuer's credit quality refers to the ability of the issuer to repay the debt, as perceived by the market and expressed in terms of credit ratings assigned. Average credit quality for bond portfolios reflects average quality of constituent bonds.

Quality ratings reflect the credit quality of the underlying securities in the Fund's portfolio and not that of the fund itself. Quality ratings are subject to change. S&P and Moody's assigns a rating of AAA, Aaa as the highest to D, C as the lowest credit quality rating respectively.

Credit quality breakdown is calculated by taking the average credit quality of the two rating agencies, S&P and Moody's. If only one rating is provided, that rating will be used. Securities that are not rated by the agencies are reflected as such.

Duration: Duration is a measure of the sensitivity of bond prices to changes in yield. Effective duration measures the sensitivity of the price of a bond with embedded options to changes in interest rates, taking into account the likelihood of the bond being called, put and/or sunk prior to its final maturity. The duration may include the impact of derivatives.

Expense Ratio: The expense ratio is the annual fee that all funds charge their shareholders. It expresses the percentage of assets deducted each fiscal year for fund expenses, including management fees, administrative fees, operating costs, and all other asset-based costs incurred by the Fund. Portfolio transaction fees, or brokerage costs, as well as front-end or deferred sales charges are not included in the expense ratio. The expense ratio, which is deducted from the fund's average net assets, is accrued on a daily basis.

Turnover: The lesser of purchases or sales of non-cash securities divided by total net assets.

INDICES/BENCHMARKS: Indices are baskets of securities (hypothetical and unmanaged). They can be used as benchmarks against which the performance of an individual investment or portfolio can be measured. The indices listed in this section may be used as primary/secondary benchmarks

for the various investment strategies offered through the Advisory Services programs as well as proxies for various market segments within a Returns Based Style Analysis.

The Bloomberg Barclays Global Aggregate Index provides a broad-based measure of the global investment-grade fixed income markets. The three major components of this index are the U.S. Aggregate, the Pan-European Aggregate, and the Asian-Pacific Aggregate Indices. The index also includes Eurodollar and Euro-Yen corporate bonds, Canadian government, agency and corporate securities, and USD investment grade 144A securities. Constituents must be rated investment-grade (Baa3/BBB- or higher) by at least two of the following ratings agencies: Moody's, S&P, Fitch. If only two of the three agencies rate the security, the lower rating is used to determine index eligibility. If only one of the three agencies rates a security, the rating must be investment-grade. Unrated non-U.S. bonds may use an implied issuer rating to determine index eligibility when not rated by an agency.

SEC Yield: The 30-Day Yield (subsidized) represents net investment income earned by the Fund over the 30-Day period ended 12/31/2020, expressed as an annual percentage rate based on the Fund's share price at the end of the 30-Day period. The 30-Day unsubsidized SEC Yield does not reflect any fee waivers/reimbursements/limits in effect.
