

#### MANAGER COMMENTARY

We believe we are in the middle of a new economic cycle and expect continued upside for risk assets over the next 12 months. The successful rollout of COVID-19 vaccinations is helping the economy recover and is boosting company earnings, pushing markets to trade near all-time highs. Inflation and Fed policy remain top-of-mind, and we expect rates to rise modestly towards year-end and believe that inflation will remain contained. In the near-term, we are closely watching the data to see how the Delta variant could affect economic and corporate fundamentals. Overall, our portfolios are positioned pro-cyclically and we are prepared to add further risk if the opportunity arises.

# **FUND ALLOCATION** 9/30/2021







#### **GLOSSARY OF TERMS**

**Annualized Performance:** This is used to show performance for periods of greater than one year and is also called compound rate of return.

Annualized return measures an investment's increase in value each year, including capital appreciation and reinvested income.

**Expense Ratio:** The expense ratio is the annual fee that all funds charge their shareholders. It expresses the percentage of assets deducted each fiscal year for fund expenses, including management fees, administrative fees, operating costs, and all other asset-based costs incurred by the Fund. Portfolio transaction fees, or brokerage costs, as well as front-end or deferred sales charges are not included in the expense ratio. The expense ratio, which is deducted from the fund's average net assets, is accrued on a daily basis.

**Turnover:** The lesser of purchases or sales of non-cash securities divided by total net assets.

**INDICES/BENCHMARKS:** Indices are baskets of securities (hypothetical and unmanaged). They can be used as benchmarks against which the performance of an individual investment or portfolio can be measured.
