MANAGER COMMENTARY

While we believe we are moving into later part of the economic cycle and anticipate lower economic growth in 2022 vs. 2021, we expect continued upside for risk assets over the next 12 months. U.S. economic output and company earnings are well-above pre-COVID levels, but inflation is high and remains significantly higher than the Fed's 2% target. Russia's invasion of Ukraine has also caused some to question the durability of this cycle. The Fed began hiking rates in March and will continue to do so until inflation and growth slow to more sustainable levels, but we think that the Fed will be able to moderate inflation without ending the economic cycle. Overall, our broader portfolios are pro-cyclically positioned, and we would consider adding further risk, prudently, if the opportunity arises.

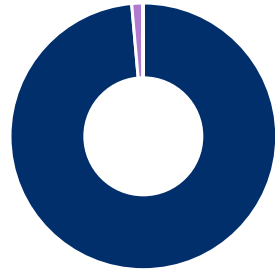

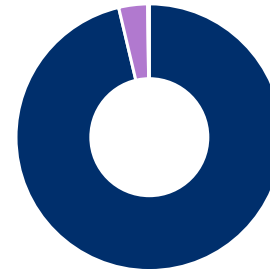

Fund Performance

Annual Operating Expenses

Morgan Private Investments Inc., and/or its affiliates have contractually agreed through at least 04/30/2023 to waive any management fees that exceed the aggregate management fees the adviser is contractually required to pay the Fund's sub-advisers. Such waivers are not subject to reimbursement by the Fund.

Additionally, the Fund's Adviser has contractually agreed through at least 04/30/2023 to reimburse expenses to the extent total annual operating expenses of a Fund excluding acquired fund fees and expenses, if any, dividend and interest expenses related to short sales, brokerage fees, interest on borrowings, taxes, expenses related to litigation and potential litigation and extraordinary expenses) exceed 0.45% of the average daily net assets of the Fund, respectively (the "Expense Cap"). GLOSSARY OF TERMS

Annualized Performance: This is used to show performance for periods of greater than one year and is also called compound rate of return. Annualized return measures an investment's increase in value each year, including capital appreciation and reinvested income.

Expense Ratio: The expense ratio is the annual fee that all funds charge their shareholders. It expresses the percentage of assets deducted each fiscal year for fund expenses, including management fees, administrative fees, operating costs, and all other asset-based costs incurred by the Fund. Portfolio transaction fees, or brokerage costs, as well as front-end or deferred sales charges are not included in the expense ratio. The expense ratio, which is deducted from the fund's average net assets, is accrued on a daily basis.

Turnover: The lesser of purchases or sales of non-cash securities divided by total net assets.

INDICES/BENCHMARKS: Indices are baskets of securities (hypothetical and unmanaged). They can be used as benchmarks against which the performance of an individual investment or portfolio can be measured. The indices listed in this section may be used as primary/secondary benchmarks for the various investment strategies offered through the Advisory Services programs as well as proxies for various market segments within a Returns Based Style Analysis.
