

## INFORMATION REGARDING YOUR 2023 DISTRIBUTIONS

### SIX CIRCLES FUNDS

**NOTICE REGARDING SOURCES OF DISTRIBUTION (December 2023)** – We are providing shareholders of the Six Circles Ultra Short Duration Fund (the "Fund") with an estimate of the source of the Fund's 2023 distributions (as listed below) as required by current securities laws. Section 19(a) of the Investment Company Act of 1940 requires the payment of any distribution to be accompanied by a written notice that discloses the sources of a payment if it is made from any source other than a fund's net income. This notice is intended to satisfy the requirements under Section 19(a). The Fund estimates that a portion of the year to date distributions for the fiscal year 2023 are comprised of Return of Capital. This estimate is based on information as of December 31, 2023.
