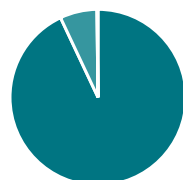

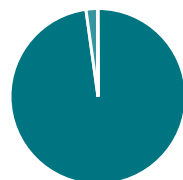
PORTFOLIO COMPOSITION 7/16/2021

MARKET CAP



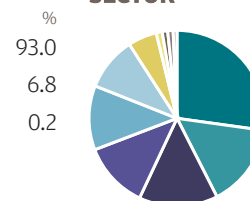
