INVESTMENT OBJECTIVES AND STRATEGY

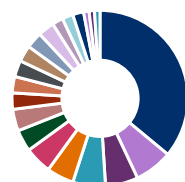

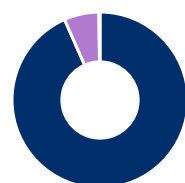

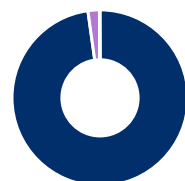
