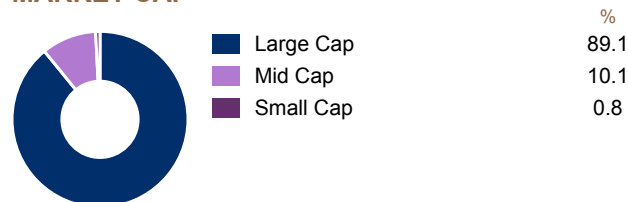

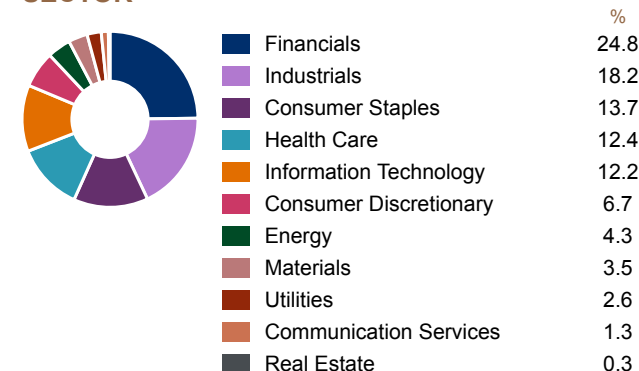

PORTFOLIO COMPOSITION 4/4/2025

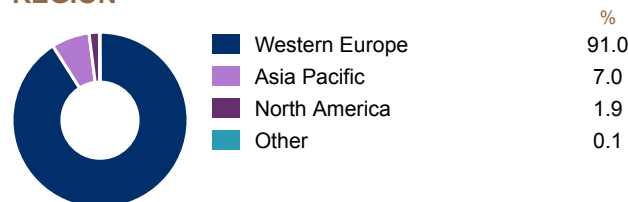
